

Luther Manor Continuing Precautions Related to COVID-19

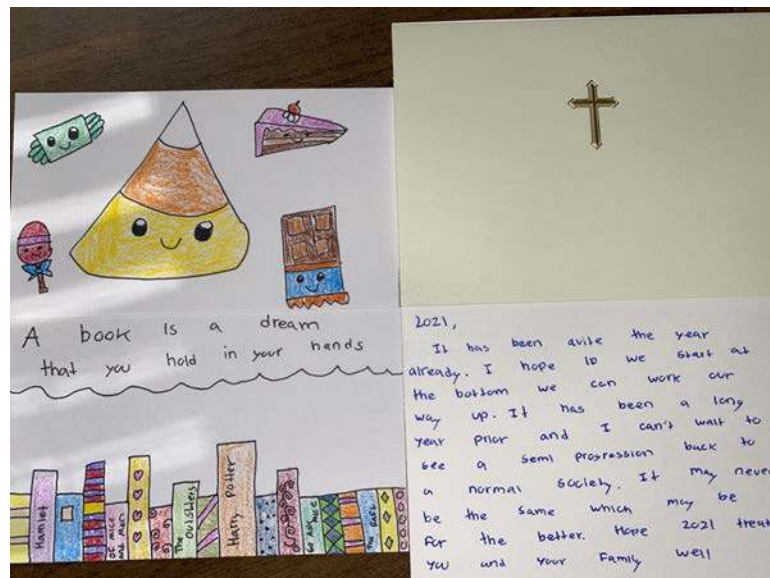

- As we have mentioned previously, the federal Pharmacy Partnership Program only allowed for three vaccination clinics per facility to jump start getting vaccines to seniors and staff who care for them. Our March 2 clinic will be our final clinic under this federal program. Having known this was not a long term solution for us, we have been working since last year to find a solution to offer vaccinations in the future. We have a solution mapped out but do not have confirmation from the government that vaccines will be allocated yet. We are exploring other options as well, so will keep you updated as the details are confirmed. We know that the second Moderna vaccine cannot be administered any sooner than 28 days after the first and no later than 42 days (according to the CDC) or 56 days after (according to Walgreens) so we have some time to finalize things. Fortunately, seniors and health care workers are a priority for the vaccine so if all else fails, the second dose could be administered at a Walgreens clinic.
