### Campus Update

- **Our Courtyards program remains in quarantine** following the staff COVID case that was discovered over the weekend. All unvaccinated residents and all staff were tested again. We expect results back within the next few days. No one has exhibited signs or symptoms of COVID so we are hoping for the best. That said, until test results are back, our Phase III reopening is on hold. Despite the

fact that the reopening phase is on hold, we continue to put all the plans in place so as soon as we can, we are ready to welcome you back and implement resident activities and visitation. **One point of clarification is needed regarding in-person visits.** To manage the number of people in the building at any time, we will be scheduling 5 visits per day, M-F. In order to allow all 75 residents the opportunity to have an in-person visit during this phase, a 2nd visit for any resident will be scheduled upon availability after each resident has had the opportunity for a 1st visit. Again we appreciate your patience and excitement as we go through this next phase. - **In the Health Care Center and at River Oaks**, our Phase III plans are moving ahead for an April 5 implementation. In addition, with Easter coming, residents can leave with family members on Sunday, April 4th **for scheduled outings**. If the resident has received their second COVID vaccination by March 22nd they will not require isolation upon their return. If they have not, they will need to be placed in isolation after the outing. **Please schedule your Easter Sunday pickup with your loved ones' Life Enrichment Coordinator or Unit Secretary.** We want to be sure we have them ready and coordinated with all other residents being picked up in addition to the resident services that day.
- **Phase III reopening in the Terrace Independent Living is going well.** Thank you all for your cooperation while we ease back into “normal.”
